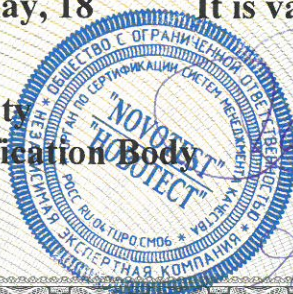

1 Type of products (services):

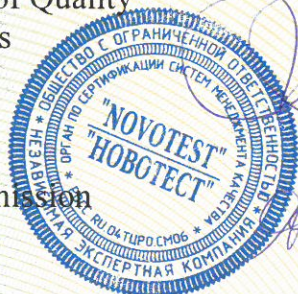
